It is with great pleasure that we present the Plumbing Industry Climate Action Centre's (PICAC) Annual Report for the Financial Year 2022-2023 (FY22-23). This report highlights some of the accomplishments from the past year, offering a window into the implementation of PICAC's Strategic Plan as the Organisation seeks to move forward from the impacts of the COVID-19 Pandemic.

At PICAC, we maintain a commitment to fostering opportunities that amplify growth, employment prospects and investments in the Australian Plumbing and Fire Protection Industry. Our approach is underpinned by robust Industry collaborations, with a focus on innovation aimed at addressing the evolving needs of the workforce.

A shining testament to this commitment was the inauguration of the Hydrogen Centre of Excellence at the PICAC Beenleigh campus during FY22-23. This cutting-edge training facility, opened by Queensland Premier Annastacia Palaszczuk MP in November 2022, stands ready to empower Queensland's gasfitting workforce to unlock the potential of renewable hydrogen. Supported by a substantial \$20 million investment by the Queensland Government, this transformative project will enable PICAC Beenleigh to offer a range of new training to assist in Australia's energy transition.

Across our VIC, NSW, and QLD campuses, FY22-23 witnessed a remarkable accomplishment, with over 8,400 apprentices and posttrade learners benefitting from more than 432,000 hours of training. This significant feat represents the highest number of training hours recorded in PICAC's history and is particularly noteworthy given the formidable challenges faced by the Australian Construction Industry in the post pandemic environment.

The resilience demonstrated by PICAC's trainers, administrative



personnel, and operational staff in the face of the pandemic's lingering effects is truly commendable. This adaptability has allowed PICAC to deliver exemplary training that yields tangible employment outcomes for both apprentices and the Industry as a whole.

In FY22-23 several new initiatives were launched in line with PICAC's mission of offering training programs that prepare our Industry for future job demands. One significant initiative focused on enhancing skill sets for the evolving energy landscape. In collaboration with Solar Victoria, PICAC introduced a specialised training program designed to equip Victorian plumbers with the necessary expertise to design and install energyefficient heat pumps and solar hot water systems. This program plays a crucial role in ensuring that our Industry maintains a leading position in the renewable and clean energy sectors.



Throughout FY22-23, our campuses nationwide have hosted numerous events and sessions to support PICAC's commitment to collaborate with local Industry and communities. These initiatives span a wide spectrum, encompassing endeavours like navigating the energy transition, empowering women in plumbing, fostering the mental well-being of young apprentices and supporting flood rehabilitation. These partnerships reinforce PICAC's pivotal role in creating connections well beyond the campus.

Furthermore, FY22-23 marked a resurgence of in-person festivities commemorating World Plumbing Day in March 2023. This year, PICAC campuses in Victoria, NSW, and Queensland played host to a range of Industry events aimed at honouring the numerous contributions made by skilled plumbing professionals and underscoring the vital role plumbing plays in upholding societal well-being.

A standout feature of this occasion was the Apprentice Skills Contest, which

saw 12 apprentices from Victoria, QLD and NSW compete for the titles of best Plumbing and best Sprinkler Fitting apprentice. The finalists from this competition then went on to vie in the United Association International Skills Competition in Ann Arbor, Michigan in August 2023, showcasing the best of Australia's Plumbing and Sprinkler Fitting Industry on a global stage.

In FY22-23, PICAC celebrated its third full year of delivering Plumbing Apprenticeship and post-trade training in NSW at the PICAC Glenwood Campus in Sydney. PICAC Glenwood is set to grow into a world-class training facility for the NSW Plumbing and Fire Protection Industries, thanks to a \$25 million investment from the NSW Government earmarked for campus expansion. This funding will play a crucial role in allowing STC to meet the increasing training demand in the burgeoning hydrogen sector and address the evergrowing need for skill development in the years ahead.

It was extremely pleasing to see continued growth in our developing operations in Sydney with both Plumbing and Fire Protection apprenticeships now firmly established and growing. PICAC Glenwood is proud to be NSW's only medical gas training provider, ensuring that those working in this vital area have the skills and competencies needed to work safely.

PICAC eagerly anticipates another year of collaborative efforts with our dedicated staff and Stakeholder partners as we forge ahead in the journey defined by our strategic vision. We would like to extend our thanks to the PICAC Board for their leadership and direction during FY22-23 and to our staff and Industry partners for their dedication and hard work throughout a demanding year.

PICAC's dedication to expanding access to world-class Plumbing and Fire Protection training remains as strong as ever. We look forward to driving our commitment to excellence onwards in the forthcoming Financial Year.

The new Centre consists of state-ofthe-art training areas, with separate zones where vocational training can be undertaken safely on regulated supplies of hydrogen. The facility also boasts environmentally conscious technology enhancements including a rooftop PV solar array, specialised fire systems and stateof-the-art training spaces for apprentices and post-trade learners. With the new facility open, PICAC Beenleigh stands as a shining example of a world-class training institution and will help ensure that the **Queensland Plumbing** 



and Fire Protection Industry stays at the cutting edge of the transitioning energy sector.

The PICAC Hydrogen Centre of Excellence represents a shared vision between Industry and Government around the significance of the green hydrogen opportunity.





The development of the facility has been made possible by a \$20 million investment by the Queensland Government and represents a successful Industry partnership between STC, PICAC, the Plumbing and Pipe Trades Employees Union QLD (PPTEU), the Master Plumbers' Association of Queensland (MPAQ) and the National Fire Industry Association (NFIA).

In the wake of the enduring effects of the COVID-19 pandemic on our Industry amid Australia's postpandemic recovery, STC remained steadfast in its commitment to providing top-quality training services for Queensland and NSW. While STC is not shielded from the global trends and Industry challenges, it remains unwavering in its dedication to consistently achieve exceptional results and set a standard of excellence.

In FY22-23, STC continued its focus on enhancing the student experience and facilitating their progression, all with the overarching goal of securing the future of its Industry. ## World Plumbing Day 2023

In honour of World Plumbing Day, PICAC organised a range of events on Friday, 10 March 2023 at our campuses in Victoria, NSW and QLD to commemorate the significance of plumbing and the work of licensed plumbers.

## Victoria

PICAC's Brunswick Campus hosted a morning tea to celebrate Women in Plumbing in honour of World Plumbing Day. The event featured inspiring guest speakers who shared their stories and knowledge of all things plumbing.

One of the highlights of the event was a panel discussion featuring Jackie Sims-Coutts, a licensed plumber, and Amy Kosterman, a licensed sprinkler-fitter, who both discussed their personal experiences in the Plumbing and Fire Protection Industries. They emphasised the importance of

## **New South Wales**

At the opening event, the Queensland Premier was joined by Queensland Treasurer and Minister for Trade and Investment Cameron Dick MP, Minister for Energy, Renewables and Hydrogen and Minister for Public Works and Procurement, Mick de Brenni MP, Minister for Employment and Small Business and Minister for



Training and Skills Development, Di Farmer MP and Attorney-General and Minister for Justice, Minister for Women and Minister for the Prevention of Domestic and Family Violence, Shannon Fentiman MP, amongst over 150 Industry participants, apprentices and post-trade learners. The development of the facility has been made possible by a \$20 million investment by the Queensland Government





and represents a successful Industry partnership between PICAC, the PPTEU Queensland, MPAQ and the NFIA.

This advanced facility holds the key to shaping the upcoming generation of hydrogen experts specialising in renewable energy. Annually, more than 1,000 trainees and apprentices in Queensland can access this cutting-edge training centre. Its offerings include specialised equipment for gas training, technology upgrades promoting reduced carbon footprint, elevated work platforms for roof access, and state-of-the-art training rooms, all contributing to a world-class learning experience.

With the opening of the Hydrogen Centre of Excellence, PICAC is providing training with real, long term employment outcomes and creating a great legacy for future generation of skilled Plumbing and Fire Protection professionals right across Australia.
