On behalf of the Plumbing Industry Climate Action Centre (PICAC) and its Board, it is our pleasure to present the Annual Report for the Financial Year 2023-2024 (FY23-24). This year has been a landmark period for PICAC, filled with significant achievements and milestones that reflect our ongoing commitment to delivering Industry-leading training to learners across Australia.

PICAC's core mission is to create a dynamic learning environment where plumbing, sprinkler fitting, HVAC, and other trade professionals are equipped with the skills needed to excel in their fields. Over the past year, we have maintained our reputation as a premier training provider, offering exemplary education across our campuses in Victoria, New South Wales, and Queensland. Central to our mission is the success of our students, which remains the guiding force behind our strategic direction.

In FY23-24, we reached a recordbreaking 550,000 hours of training delivery, benefiting over 10,000 learners nationwide—a remarkable 22% increase from the previous year. These results demonstrate the effectiveness of PICAC's collaborative approach, which spans the entire career lifecycle of our learners and fosters enduring partnerships within the Australian plumbing and fire protection industries. Our training programs continue to evolve, ensuring that the workforce of tomorrow is prepared for the challenges and opportunities brought by innovation and change in the Industry.

In FY23-24, several new initiatives were launched in line with PICAC's mission of offering training programs that prepare our Industry for future job demands. One significant initiative focused on enhancing skill sets for the evolving energy landscape. In collaboration with Solar Victoria, PICAC introduced a specialised training program designed to equip Victorian plumbers with the necessary expertise to design and install energy-efficient heat pumps and solar hot water systems. This program plays a crucial role in ensuring that our Industry maintains a leading position in the renewable and clean energy sectors.

Our commitment to student success extends well beyond the classroom. In FY23-24, PICAC actively supported a range of community initiatives that provided apprentices with opportunities to apply their skills while giving back to our community. In August 2023, we partnered with the International Water, Sanitation and Hygiene Foundation (IWSH) on a project at the Yooralla Community Business Hub in Shepparton, where PICAC apprentices replaced essential plumbing fittings. These communitybased projects not only enrich our apprentices' learning experiences but also strengthen their connection to the Industry and the communities in which they live and work.

PICAC also proudly supported initiatives like the AFL Finals Series Luncheon, a fundraising event for the Indigenous Plumbing & Sanitation Foundation and Big Brothers Big Sisters of Australia, and contributed to the Bravery Trust charity through the AFL Plumber's Team of the Century Dinner. These efforts reflect PICAC's deep commitment to community causes, furthering our impact beyond the boundaries of our campuses.

Throughout the year, PICAC remained dedicated to enhancing the student experience with events that celebrate and uplift our Industry's future talent. 2023 culminated in the inaugural PICAC Graduation and Awards Dinner, celebrating the accomplishments of our graduating plumbing and sprinkler fitting apprentices from the PICAC Glenwood Campus. This event was a significant milestone for both the graduates and PICAC, highlighting our role in shaping the future of the Plumbing and Fire Protection Industries in NSW.

A major feature of our World Plumbing Day festivities was the Annual PICAC Apprentice Skills Contest, held in March 2024 at our Brunswick Campus. The competition brought together 17 apprentices from across Australia, competing for the titles of Best Plumbing Apprentice and Best Sprinkler Fitting Apprentice. The winners of this contest proudly represented Australia at the United Association International Skills Competition in Ann Arbor, Michigan, in August 2024, where they showcased their exceptional talents on the global stage.

As we look to the future, PICAC's 2021-2026 Strategic Plan continues to guide our organisation's growth and transformation. This strategic framework is designed to ensure PICAC's sustainability and adaptability in a rapidly changing Industry landscape.





One of the year's standout achievements was the announcement of the \$25 million redevelopment of our Glenwood Campus in Sydney, which will include the PICAC Hydrogen Centre of Excellence. As the importance of skilled labour in our energy industries becomes increasingly critical to the economic future of Queensland and Australia, STC's training at PICAC Beenleigh is designed to meet the growing need for advanced technical skills. We are committed to equipping our workforce with the tools they need to drive the sustainable energy transition and future-proof the Industry.

Throughout FY23-24, STC collaborated closely with

government, Industry, and the community, all while drawing inspiration from our exceptional students.

In FY23-24, STC strengthened its commitment to inclusivity by partnering with the National Association of Women in Construction (NAWIC) to host events that promoted women's participation in Plumbing and Fire Protection. These efforts celebrated the achievements of women in the field and encouraged others to explore the





rewarding career pathways available in the Industry. STC also collaborated with Mates in Construction to raise mental health awareness through workshops and training. These initiatives highlighted the importance of mental well-being in the trades and reinforced STC's dedication to supporting a diverse and healthy workforce.

World Plumbing Day, celebrated on 11 March 2024 at the PICAC Beenleigh Campus, was a highlight of the year, showcasing STC's commitment to engaging future tradespeople and promoting the importance of the plumbing Industry. The event commenced with a "Try a Trade" activity, welcoming over 60 students from ten local high schools. These students had the opportunity to participate in handson demonstrations across three trade stations, complemented by a classroom briefing led by STC and Fire Industry Training (FIT) apprentices and trainers. The event provided valuable insights into the diverse and exciting career paths available in Australia's Plumbing and

Fire Protection Industries. The World Plumbing Day celebrations continued with an Apprentice lunch, attended by approximately 100 apprentices on-site. Industry representatives delivered speeches that underscored the Plumbing Industry's essential role in safeguarding community health and wellbeing, as well as highlighting the extensive career opportunities within the Industry. These discussions also emphasised the collaborative efforts of associations and unions in advancing trade training.

In FY23-24, STC proudly celebrated the success of many of our learners who achieved remarkable milestones. A standout moment was the exceptional performance of plumbing apprentice Jack Keogh, a finalist in the 2023 PICAC Apprentice Skills Contest. His accomplishments earned him the honour of representing Australia at the UA International Apprentice Competition, where he competed admirably against peers from the USA, Canada, and Ireland. Additionally, QLD STC and FIT apprentices competed in the



March 2024 PICAC Apprentice Skills Contest, with Sam Barnes securing his spot to represent Australia in the 2024 UA Apprentice Skills Contest overseas.

As we move into the new Financial Year, STC remains dedicated to providing quality training and skills development in the Plumbing Industry, continuing its commitment to connecting people with valuable opportunities. We extend our deepest gratitude to our dedicated trainers, administrative, and operational staff for their tireless efforts and contributions throughout FY23-24.

HIGHLIGHTS FY 2023-2024

World Plumbing Day 2024

11 March 2024

Every year, World Plumbing Day serves as a reminder of the critical role plumbing plays in safeguarding public health and maintaining environmental sustainability. It is a day to recognise the dedicated efforts of skilled, licensed plumbers who ensure clean water and safe sanitation for our homes, communities, and environment.

In 2024, PICAC celebrated World Plumbing Day with events and activities spanning across our campuses in Queensland, Victoria and New South Wales.

Queensland

At the PICAC Beenleigh Campus in Queensland, World Plumbing Day commenced on Monday 11 March 2024 with a "Try a Trade" event for school aged learners. Students from ten local high schools were given the unique opportunity to explore the career pathways within plumbing and fire protection through a series of interactive stations, engaging activities, and informative sessions. Throughout the day, students interacted with industry professionals and PICAC apprentices, offering them valuable insights into the daily life of an apprentice in both the Plumbing and Fire Protection sectors.

The day continued with a lunch for all PICAC Beenleigh apprentices and post trade learners, accompanied by addresses from Industry representatives emphasising the importance of World Plumbing Day and the value of trade careers. Speakers included Executive Director of the Master Plumbers' Association of QLD, Penny Cornah, State Secretary of the QLD Plumbers Union, Gary O'Halloran and President of the National Fire Industry Association of Australia, Andrew Hickman.

New South Wales

PICAC celebrated World Plumbing Day at the Glenwood NSW Campus by hosting a series of events that highlighted the hard work and achievements of our plumbing and sprinkler-fitting apprentices. The day commenced with a special luncheon, bringing together apprentices, trainers, and industry representatives to celebrate the critical role that skilled trades play in safeguarding community health, safety, and well-being. This luncheon provided an excellent opportunity to acknowledge the dedication of our apprentices and highlight the pathways available within the Plumbing and Fire Protection industries.

In addition to the luncheon, PICAC Glenwood hosted a sprinkler-fitting apprentice competition, designed specifically for third-year Fire Industry Training apprentices. Victoria

2023 United Association (UA) International Apprentice Competition

11-17 August 2023



In August 2023, Queensland Plumbing Apprentice Jack Keogh and Victorian Sprinkler-fitting Apprentice Steve Barbeta travelled to Ann Arbor, Michigan USA to compete in the United Association's International Apprentice Skills Contest.

Jack and Steve were both finalists in the annual World Plumbing Day Apprentice Skills Contest held at PICAC Brunswick in March 2023, which qualified them to take part in the selection process for eligibility in the overseas competition. Both apprentices stood out for their professionalism, integrity and Industry commitment, making them ideal ambassadors to represent PICAC and Australia at the UA International Apprentice Skills Contest. The UA International Apprentice Skills Contest is a fiveday intensive competition which tests a range of industry related skills. Competing against the Australians were a number of highly skilled apprentice plumbers, pipefitters, sprinkler fitters, mechanical service technicians and welders from Canada, Ireland and the United States.

Jack and Steve both performed very well and earned the respect of their international counterparts. Since returning to Australia, both contestants have continued to act as ambassadors for their trades. In March 2024, Both Jack and Steve returned to PICAC's World Plumbing Day Apprentice Skills Contest to serve as mentors for the next wave of competitors.





IWSH Plumbing Champions Project at Yooralla Mooroopna

17-23 August 2023



PICAC was proud to partner with the International Water, Sanitation and Hygiene Foundation (IWSH) to deliver a Plumbing Champions social project during the WorldSkills Australia National Championships & Skills Show, held from 17–19 August 2023, at the Melbourne Convention and Exhibition Centre.

The Plumbing Champions initiative, developed by IWSH and the World Plumbing Council, is designed to inspire young people to explore careers in the plumbing and pipe trades. This ongoing program celebrates the expertise of the Plumbing Industry while demonstrating the impactful role proper plumbing systems play in local communities. Through skills competitions and trade show activities, it showcases how technical knowledge can deliver meaningful benefits to society.

For the August 2023 event, PICAC collaborated with IWSH to design, build, and donate new handwashing facilities to the Yooralla Business Enterprise site in Mooroopna, Victoria. Yooralla, one of Australia's largest and oldest not-for-profit disability service providers, supports individuals with disabilities across Melbourne and regional Victoria, creating opportunities for meaningful and empowering career pathways. The Plumbing Champions project was a meaningful way for PICAC, IWSH, and WorldSkills Australia to contribute to the vital work done by Yooralla's members and staff.

The facilities were fabricated on-site during the WorldSkills National Championships by 12 apprentices from across Australia as part of the Plumbing Competition. Once completed, the handwashing stations were transported to Yooralla Mooroopna for installation. Apprentices from RAW GTO, Jackson Vinney, and Kaleb Hudson played a key role in the installation, working closely with PICAC, IWSH, and Yooralla staff.

The final installation included 16 individual handwashing basins with hot and cold water: eight in the main workshop area and four in each of the male and female bathrooms. These upgrades significantly enhanced the hygiene facilities available at the site.

PICAC is proud to support the IWSH Plumbing Champions program and looks forward to future collaborations that empower communities and highlight the critical role of the Plumbing Industry in improving lives.



Introducing the **PICAC Glenwood Hydrogen Centre of Excellence**



In 2023, PICAC proudly announced, in partnership with the NSW Government, the establishment of the \$25 million Hydrogen Centre of Excellence. This future-focused development was unveiled by Premier Chris Minns, alongside Minister for Skills, TAFE and Tertiary Education Steve Whan and Minister for Climate Change, Energy, and the Environment Penny Sharpe, during a special event at the PICAC Glenwood campus. Surrounded by apprentices and Industry leaders, the announcement underscored the commitment to advancing skills training in emerging fields.

The Hydrogen Centre of Excellence will transform the PICAC Glenwood campus through a complete rebuild and redesign, significantly enhancing its capacity to deliver training for both apprentices and current workers. This new facility will ensure that learners are well-prepared for opportunities in emerging sectors, such as hydrogen technology, which will be essential in driving the decarbonisation of Australia's economy.

The expansion of the Glenwood campus will feature state-of-the-art, purpose-built workshops equipped with cutting-edge technology, enabling the delivery of worldclass training for the Plumbing, Mechanical, and Fire Protection Industries in NSW. The upgraded facilities will provide spacious, modern learning environments where apprentices will engage in hands-on training with advanced hydrogen equipment, including electrolysers, innovative gas-fitting techniques, and critical safety

protocols. Additionally, the construction of the Centre will create substantial employment opportunities in Western Sydney, generating 500 construction jobs and employing over 100 apprentices throughout the project.

This groundbreaking initiative is the result of a unique partnership between Industry and Government, designed to equip the workforce of the future with essential skills in plumbing, fire protection, carbon reduction technologies, and advanced gas fitting.

The establishment of PICAC Glenwood reflects the strength of collaboration among key Industry stakeholders, including the PPTEU NSW, the NFIA, and PICAC. This world-class project demonstrates the power of Industry partnership in preparing apprentices for the current and future job markets, setting a global benchmark for skills development in the hydrogen sector.
